



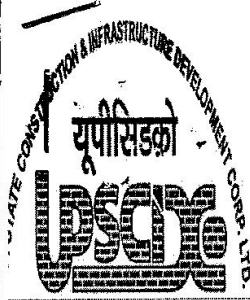

(a) Three similar completed works each costing not less than 40% of Tendered cost.

Or

(b) Two similar completed works each costing not less than 60% of Tendered cost.

(c) One similar completed work costing not less than 80% of Tendered cost.

One Completed work of same nature (either part of (i) or a separate one) costing not less than the amount equal to 40% of the estimated cost put to tender with some Central Government Department / State Government Department/Central Autonomous Body / Central Public Sector undertaking.


Similar work shall mean construction of Building work.

(ii) Should have an average annual financial turnover of 50% of estimated cost on construction work of similar nature during last three years, ending 31st March 2016 (copy of certificate from C.A. to be submitted).

(iii) Should not have incurred any loss in more than two years during the last five years. Solvency certificate form Bankers or District Magistrate to be submitted.



- (iv) Information regarding projects in hand, current litigation, orders regarding exclusion, expulsion or black listing, if any should be indicated.
- 2- The bids shall remain valid for acceptance for a period of 90 (Ninety days) from the last date of submission of bids. Bids once submitted cannot be withdrawn.
- 3- Bidders shall submit Two separate envelopes marked "A" & "B"- in one envelope.
- (a) **ENVELOPE "A"**-This envelope with 'EARNEST MONEY' & "TECHNICAL BID" written on top of the envelope shall contain Earnest Money and the documents of technical data.
- (b) **ENVELOPE "B"**- This document in envelope with "FINANCIAL BID" written on top of the envelope shall contain this Tender Document, duly signed and financial bid..
- 4- Financial bids shall be opened of those bidder whose bids are technically qualified and eligible.
- 5- A set of Bidding documents may be purchased from the office of E.E. U.P.S.C.I.D.C., Bahraich as mentioned in column-7, between 11:00 am to 04:00 pm on any working day from **07.10.2016** to **20.10.2016** for a non-refundable fee mentioned in column-5, in the form of Demand Draft drawn on any scheduled bank in favour of U.P. State Construction & Infrastructure Development Corporation Ltd, Payable at Bahraich Interested bidders may obtain further information at the same office from where the documents are purchased.
- 6- Bid must be delivered to the office of the E.E. U.P.S.C.I.D.C., Bahraich on or before 2:00 PM on **21.10.2016** and the technical bids will be opened, on **21.10.2016** at 3:00 pm in the presence of the bidders or their authorized representatives to attend, in presence of committee constituted. If the office happens to be closed on the date of receipt or opening of the bids as specified, the bids will be received and opened on the next working day, respectively at the same time and venue, and validity of bid will be considered from the original date. The financial bids of those tenderers, whose Technical bids are found in order and qualified shall be opened at the time and date intimated later to those who qualifies after finalization of technical bid in the presence of the intending tenderes or representative who may be present. (Date will be intimated after evaluation of Technical bids.)
- 7- Bids must be accompanied with earnest money of the amount specified for the work in the table. The Earnest Money may be deposited in the form of Demand Draft of a Nationalized Bank payable at Bahraich in favour of U.P. State Construction & Infrastructure Development Corporation Ltd, Bahraich. The intending bidders has to fill all the details such as Bankers name, Demand Draft, Amount and Date.
- 8- No Engineer of gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the state/ Central Government is allowed to work as a contractor for a period of two years after his retirement from government service, without Government permission. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the contractor's service. Any bidder who is having criminal record is not allowed to participate in the bidding process.
- 9- Any bidder who is registered with the state Bar council is not allowed to participate in the bidding process.
- 10- Each bidder is required to furnish in the form of an affidavit in the prescribed proforma all informations required for evaluation of the bidding capacity of the bidder. Each bidder is required to satisfy himself about his bidding capacity before submitting his bid. Bidding capacity will be evaluated as mentioned in section-3 of Bid Document. Bids of bidder who do not possess the required bidding capacity shall not be accepted in any case.
- 11- Bidder must submit all informations/ documents on prescribed proforma with each bid.
