- **Turnover**: Average Annual Financial Turnover during the last Five years, ending 31st March 2019, should be at least 50% for each work, of the estimated cost. Balance sheet along with profit & loss duly certified by chartered accountant is to be enclosed for the last five years. In case balance sheet along with profit & loss is not prepared for 2018-19, provisional balance sheet along with Profit & Loss duly certified by charted accountant is to be enclosed.
- **ii. Experience**: Applicant should have the experience of completion of similar works executed from Central / State Govt. Departments / PSUs of Central Govt. & UPSCIDCO during last 7 years ending last day of month previous to the one in which tenders are invited should be either of the following.

a. Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.

- c. One similar completed work costing not less than the amount equal to 80% of the estimated cost.
- iii. Similar Nature works mean: Civil work comprising RCC framed structure Institutional/Residential/Industrial building including services like electrification, Sanitary & Water Supply, Drainage and waste management, Road works, Fire fighting & Site development etc.
- **iv.** The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7 % per annum calculated from the date of completion to last date of receipt of applications for tenders.
- **iii. Profitability:** The applicant should be a profit (net) making firm and Should not have incurred any loss in the last 2 (two) financial years. - v. EPF Registration: Agency should have EPF registration and it should be enclosed.
- vi. Joint Venture: Joint Ventures are not permitted in any case.

Credit Facility: Applicant Agency shall have to submit Un-utilized credit facility of 10% (minimum) for each work, of estimated cost put to tender issued on or after the date of publication of Notice inviting Tender duly certified by the Nationalized Bank or schedule Bank (ICICI, HDFC & Axis)
- **viii.** The applicant must have adequate organizational setup as well as having sufficient number of experienced personnel, technical know-how, and infrastructure to complete the project well within time frame.
- ix. The applicant must have minimum three years' experience working with public sector enterprises / government /semi government
